Introduction

In August 2011, the Minister for Environment and Climate Change requested the Victorian Environmental Assessment Council (VEAC) to investigate public land in the Yellingbo area, focusing on the biodiversity and ecological values, and make recommendations for appropriate management arrangements to conserve and enhance these values.

In July 2013, VEAC completed the Yellingbo Investigation Final Report (VEAC report) which made recommendations to recognise the high conservation values in parts of the area and to build on the existing collaboration in managing the land by the community, local governments and State government. The principal recommendation is that areas of Crown land within the investigation area be added to a new Schedule Four A 'Conservation Landscapes' created for the protection of fragmented public land within specified landscapes and for the integrated management of the designated land for nature conservation. It also recommended that Parks Victoria (PV) be appointed as the ongoing delegated land manager for the majority of the reserve.

In its response in March 2014, the Victorian Government largely accepted the recommendations of the VEAC report and committed to establishing the Yellingbo Conservation Area (YCA). The extent of its acceptance of the recommendations is set out in the Victoria Government Response to the Victorian Environmental Assessment Council's Yellingbo Investigation Final Report (Government report).

On the 19th January 2017, in response to local community concern regarding revegetation and bushfire risk, the Minister of Energy, Environment and Climate, the Hon Lily D'Ambrosio, announced restriction of streamside revegetation to a maximum of 10 metres on each side of the waterways in the north-east corner of the YCA. In addition, no revegetation will occur in this area until the bushfire planning process is complete.

Yellingbo Investigation Area

The Yellingbo Investigation Area (51,370 Ha) is centred on the Yellingbo township, about 50 kilometres east of Melbourne. It includes the towns of Woori Yallock, Launching Place, Yarra Junction, Hoddles Creek, Cockatoo, Emerald, Monbulk and Seville. Most of the investigation area is within the Local Government Area of Yarra Ranges Council with approximately 12% of the land area within the Local Government Area of Cardinia Shire Council. Most of the investigation area is also within the largest of Melbourne's designated Green Wedges, namely the Yarra Valley, Yarra and Dandenong Ranges Green Wedge. The investigation area incorporates approximately 5,990 Ha of Crown land, some of which is proposed to be incorporated into a new conservation area.¹

Funding

The Victorian State Government has allocated \$3.2 million to implement the Government supported VEAC recommendations. The State government is supportive of additional resources being allocated for biodiversity conservation, pest plant and animal control, and fire management and preparedness. Land managers will be responsible for identifying priority areas where funding is needed to support the recommendations.²

As of November 2018, \$1,524,565.00 remained.

Yellingbo Conservation Area Coordinating Committee

The Government response to the VEAC report supported the creation of a coordinating committee 'to oversee and coordinate land management for nature conservation and biodiversity programs, ... set strategic directions and policies [and] guide the implementation of the Conservation Area'.³ In December 2015, the Minister appointed this committee known as Yellingbo Conservation Area Coordinating Committee (YCACC) which also has a role "to increase the profile of the biodiversity and ecological values of the area and their protection'. 


FIGURE 1: YCACC ORGANISATIONAL CHART

It is noted that VicRoads manages roadside verges that abut the YCA and similarly there are Trust for Nature properties that abut the YCA that are managed for environmental purposes.

It is also noted that the Victorian Government Yarra River Protection (Wilip-gin Birrarung murron) Bill 2017 will have an impact on current and future planning in the YCA.



Second Year Action Plan Report

YCACC is obliged to develop successive three-year action plans for the ten years term specified in the YCACC Terms of Reference.

The initial three-year Action Plan was developed during 2017 and submitted to the Minister of Energy, Environment and Climate, the Hon Lily D'Ambrosio alongside the 2017 YCACC Annual Report in December 2017.

This report updates the status of all goals, key performance indicators and actions action identified in the 2017- 2019 Action Plan as of November 2018. The progress, achievements, obstacles and delays in the journey to establishing the YCA during 2018 are discussed in more detail in the 2018 YCACC Annual Report.

Based on the VEAC Report recommendations of as endorsed by the Victoria Government, the 2017- 2019 Action Plan identifies nine Goal Areas, 28 Key Performance Indicators and 70 Actions. These actions are mapped against specific VEAC approved recommendations.

In summary this report demonstrates that:

- progress has been made to some degree in all of the goal areas (mostly in Goals 1,3, and 5; less likely in Goals 2, 4, 8 and 9);
- much of the work in each of the goal areas is ongoing;
- of the 70 action items identified, 20% (n=14) have been completed, 41% (n=29) are ongoing [or data has not been provided to YCACC], 39% (n=27) are not started yet; and
- much work is still required to implement the VEAC Recommendations as approved.

Whilst progress has been made to some degree in planning (Bushfire Plan, Draft 10-Year YCA Plan, Communication and Engagement Plan, for example), the concomitant monitoring and evaluation processes have not been progressed thus limiting capacity to evaluate outcomes or achievement of Key Performance Indicators. Little progress has been made in mapping – whilst mapping the boundaries of the YCA has commenced, mapping the values of the YCA beyond broad precinct descriptors not commenced. Whilst there has been some cancellation of licences and some work done in developing new riparian management licences, required development of management agreements and conservation agreements has not commenced. Development of the required legislation has not commenced. Most importantly, the securing of ongoing resources to establish the YCA has not commenced.

Given the dissolution of YCACC there is a legitimate concern that the Action Plan will not be continued.

During this period, three community drop in sessions were held, supported by six smaller 'pop-up' sessions.

1. Yellingbo Conservation Area Action Plan

The Yellingbo Conservation Area Coordinating Committee is required under its terms of reference to prepare the YCA Action Plan for priority land management programs in the area. The Action Plan will:

- (a) establish strategic priorities and clear directions for the area to assist land managers, local government, and the community to work in partnership to achieve better environmental outcomes in the area;
- (b) articulate the links between the plan and strategic or management plans produced by represented public land managers;
- (c) subject to the endorsement of represented public land managers, establish priority land or biodiversity actions within the area that increase the profile of the biodiversity and ecological values of the area;
- (d) identify resources and partnerships essential to the achievement of the identified priority actions; and
- (e) prioritise actions by consideration of the most efficient and effective application of public funds.

In addition, the committee is required to review and update the plan every three years and in preparing or reviewing the plan the committee must consult with reserve users and other relevant stakeholders.




FIGURE 2: STATUS OF ACTION ITEMS

Figure 1 provides an overall summary of the status of the action items identified in this plan. Of the 70 action items identified 20% (n=14) have been completed, 41% (n=29) are ongoing [or data has not been provided to YCACC], 39% (n=27) are not started yet.



To carry out the specific responsibilities in the Minister's Terms of Reference, the Yellingbo Conservation Area Coordinating Committee has identified the following actions:

Goal: To fulfil the Minister's Terms of Reference.

2. Establishment of the Yellingbo Conservation Area

The formal establishment of the YCA seeks the ongoing protection of the YCA through appropriate reservation status and ongoing management arrangements. Ultimately it is proposed that the YCA become part of a new Schedule Four A under the *National Parks Act 1975* and that Parks Victoria be appointed as the ongoing land manager for most the land.

The process for formally establishing the YCA includes the identification of Crown land to be incorporated into the new reserve, revoking the existing reservation status where needed and reserving the land under the new Schedule Four A of the *National Parks Act 1975*. As part of this process, a legislative plan is required to be prepared to identify the boundaries of the YCA.

The identification of the boundaries of the YCA may identify areas where private infrastructure has been built on Crown land. The response to these cases will be different and will be based on the conservation values in the area and the priority that is placed on the area for rehabilitation works. In some cases, boundary changes will be considered where the actual and practical boundaries differ. Any change on title will involve negotiation and agreement with the adjoining landowners and will result in no net loss of Crown land.

The new schedule will include a clause to allow the issuing of management agreements to allow the continued management of some areas by public authorities and conservation agreements to encourage adjoining landowners to continue to participate in the management of Crown land.

The Yellingbo Investigation Area contains many unused roads which may contain ecological values that are most appropriately managed as part of the YCA. These unused roads may currently be licensed by adjoining land owners, used as access points, or in some cases, not be distinguishable at ground level from the adjoining land, whether that be private or Crown land. Where these unused roads contain values that are best managed as part of the YCA, they will be formally reserved under the *National Parks Act 1975*.

As well as Parks Victoria being appointed as the ongoing land manager for the majority of the land, the Government report is supportive of other agencies also being appointed as ongoing land managers of some areas. This decision aims to recognise the existing work of other agencies in managing parts of the YCA and ensure a consistent application of management aims by including these areas in the *National Parks Act 1975*.

The Government report supported Recommendation A2 in the VEAC report which relates to the management of Coranderrk Nature Conservation Reserve by Zoos Victoria. The continued management by Zoos Victoria recognises the importance of the site for the conservation of the Helmeted Honeyeater and Lowland Leadbeater's Possum.

The Government report also supported Recommendation B in the VEAC report which states that Trust for Nature should continue to manage identified protected areas if the areas are needed by Trust for Nature. If parcels are no longer needed by the trust, the government will consider appropriate management arrangements.



Goal: To guide and coordinate the establishment of the YCA to prioritise the protection of high conservation value areas and achieve the biodiversity and water quality benefits identified in the VEAC report.

Performance Indicators:

- A new Schedule Four A under the *National Parks Act 1975* has been prepared.
- Establishment of the YCA under a new Schedule Four A in the National Parks Act 1975.
- Ongoing land managers have been identified and appointed over the YCA.
- Parks Victoria (and other agencies) supported as the ongoing land manager.

Goal: To identify Crown land boundaries within the YCA as preparation for the required legislative amendment.

Performance indicators:

3. Engaging the Community in the Establishment of the Yellingbo Conservation Area

The VEAC report, at recommendation six, provides for YCACC to be the central contact point for community engagement and liaison.

There is strong support in the Government's response emphasising the importance of engaging with the community in the process to establish the YCA. It is recognised that the successful management and implementation of the YCA is dependent on the support and local knowledge of the local communities, and this can only be gathered by directly engaging with them and including community members in the preparation of plans to guide the management of the area. Therefore, YCACC will develop an engagement and communications strategy to achieve this goal.

The Yellingbo Conservation Area Coordinating Committee acknowledges the impact that the implementation of the YCA may have on many adjoining landowners and regular communication with those who will be impacted will be essential. The major impacts to adjoining landowners are due to the cancellation of grazing licences, the potential change in land use in some areas, such as regulating recreation opportunities, the increase in native vegetation coverage and the potential for increased bushfire risk.

Goal: To engage and communicate regularly with the community in the process of establishing the YCA.

Performance indicators:

- The preparation and implementation of an engagement and communication plan.
- The community is engaged in the process of establishing the YCA in accordance with the YCACC Communications and Engagement Plan and the YCA Plan.

4. Management Agreements within the Yellingbo Conservation Area

Within the YCA, there are areas of land that are currently managed by public authorities via legislation and areas managed by adjoining land owners via licences for a range of purposes. VEAC recognised the benefits that collaborative management can play in the YCA due to the highly fragmented landscape and recommended that the *National Parks Act 1975* be amended to allow for management agreements with public authorities, and conservation agreements with adjoining land owners. The Government report is supportive of this approach.

The YCA includes areas of public land that are currently managed by public authorities. The VEAC report specified that management agreements were to be limited to public authorities such as Zoo's Victoria and local government who have an existing role in land or biodiversity management. The areas of land where conservation agreements can be entered into include Coranderrk Nature Conservation Reserve, Streamside reserves (C1-C8) and Haining Education Area (Haining Park).

The YCA also includes many areas where the adjoining landowners have been managing the land for generations for a range of different purposes. Historically, licences have been issued to adjoining land owners under both the Land Act 1958 and the *Crown Land (Reserves) Act 1978*. The purposes of these licences vary and include, conservation, riparian management, water supply, land management and grazing. Adjoining landowners have been instrumental in improving the ecological values of some areas.

The VEAC Report identified clear ecological values within the YCA and grazing is considered inconsistent with those values. However, VEAC also supported the use of contract grazing for ecological or management purposes such as targeted weed control. The Government response is supportive of using contract grazing for ecological or management purposes such as targeted weed control.

The change in agreements with adjoining landowners from licences to conservation agreements means that the existing licences are required to be phased out. VEAC recommended a time period for the phase out of licences which started in 2014. Additional licences were then phased out in 2016 and the remaining licences are scheduled to be phased out in 2018.

The quality of the riparian areas within the YCA varies greatly and many management decisions, such as the alignment of fences and the suitability of grazing as a management tool will be determined on a case by case basis. Many water frontage areas have been well managed by adjoining landowners for ecological values and those landowners have been instrumental in improving those ecological values.

Where these strong local connections to managing the water frontage areas are evident, this connection will be acknowledged and encouraged by the issue of conservation agreements.

Prior to the YCA being reserved under the *National Parks Act 1975*, and conservation agreements being entered into, DELWP intends to enter into riparian management licences for conservation purposes. This process will continue until the land is formally reserved under the *National Parks Act 1975*. These riparian management licences for conservation purposes will facilitate the removal of grazing from areas with high ecological significance while supporting the management of the Crown land by adjoining landowners.



Melbourne Water's Stream Frontage Management Program is designed to assist landowners to manage riparian areas for ecological values. Funding is available and will be prioritised for those who have a valid tenure agreement.

There are some areas that have been historically occupied and managed by adjoining landowners with no tenure agreement. Some of these areas are not appropriately managed and increased communications with these landowners will be required. In some cases, compliance action by the DELWP may be required to ensure that land is managed in accordance with the Government report.

Goal: To manage management agreements with public authorities within the YCA

Performance indicators:

- Public authorities with an existing role in land or biodiversity management have been identified.
- An established process to develop and enter into management agreements.

Goal: To manage conservation agreements with adjoining landowners within the YCA.

5. Managing Bushfire Risk

The community has expressed great concern about the potential for bushfire risk to increase following the rehabilitation of riparian areas. Concerns have also been raised about the bushfire risk associated with community infrastructure such as schools and recreation areas. This has been demonstrated through the work of the Haining Farm Working Group in developing a concept plan for the site that does not increase the bushfire risk to the community.

It is recognised that local knowledge is imperative to the development of fire management recommendations and that some areas of Crown land may be required to create an adequate fuel break to community assets and residential development.

A bushfire management plan will be prepared with the assistance of independent experts and local knowledge. The bushfire management plan will contain a range of mitigation measures that will be incorporated into the YCA Plan for the YCA. This aims to ensure that any plans to revegetate Crown land will consider local bushfire risk and assist in determining where grazing can be used as a management tool to reduce that bushfire risk. This work will also incorporate the strategic bushfire management plan for the East Central Bushfire Risk Landscape.



Recommendation A1 of the VEAC Yellingbo Investigation, highlights the need for the finalisation of the draft fire management plan for the existing Yellingbo Nature Conservation Reserve (YNCR). DELWP is responsible for managing bushfire risk on public land in Victoria. DELWP is currently preparing a fire management plan for the entire YCA which will include the existing YNCR.

Consequently, the Government will not be undertaking any revegetation within the North – East corner of the YCA until the bushfire management planning process has been finalised. In addition, the Minister for Energy, Environment and Climate Change and Minister for Suburban Development, Hon Lily D'Ambrosio has decided to limit the amount of revegetation that can occur on Crown land in that part of the YCA to a maximum of 10 metres from either side of the Yarra River and tributaries in the streamside reserves. A lesser area will be revegetated if determined through bushfire management planning, to ensure that there is no material increase in bushfire risk and that priority is given to the protection of human life and private property.

Goal: To implement the YCA in a way that does not increase the bushfire risk to the community.

To undertake a strategic landscape scale approach to fire prevention and management in the YCA.

Performance indicators:

- A bushfire management plan has been prepared that demonstrates no increase in bushfire risk as part of the implementation of the YCA;
- Monitor and report on bushfire risk mitigation in collaboration with the responsible agencies.

6. Interim Management of Yellingbo Conservation Area

The land will be managed in accordance with recommendation three in the VEAC report and as supported by the Government's response. The land will be managed in accordance with the recommendations for Nature Conservation Reserve as described in the VEAC report. This includes the following key objectives:

- The land is managed for the overall protection or enhancement of biodiversity and ecological values;
- Encourage management of the Crown land by adjacent landowners, as described in section 4 above.

A clear planning process is required to identify areas with high ecological significance to determine appropriate uses. That process has been initiated by YCACC in a mapping exercise whereby all lands in the YCA have been classified into one of the following categories, namely:

- Conservation;
- Restoration; or
- Biodiversity corridor.

Further planning work in collaboration with reserve users and the wider community is required to determine the appropriate uses. A YCA Plan is the most effective way to identify the priority areas for protection, restoration, and other uses.

Funding assistance from Melbourne Water's Stream Frontage Management Program will be provided to assist in the removal of domestic stock from areas with high ecological values and for priority site specific conservation or restoration works programs by agencies and volunteer groups.

No action will be taken to remove off-stream stock watering from Crown land where it is required to access current water allocations.

Goal: To coordinate the management of the YCA consistent with the Government supported recommendations.

Performance indicators:

Implement YCA Action Plan referencing the government supported recommendations;



- Establish a YCA Plan in collaboration with public land managers, agencies and the community in accordance with the government supported recommendations;
- All public land managers within the YCA are identified and report works and priorities to YCACC.

7. Preparation of a YCA Plan for the Yellingbo Conservation Area

A YCA Plan to guide the implementation of the YCA will be prepared as a priority to guide the early development and ongoing management of the YCA.

The purpose of the YCA Plan is to provide an overview of the planning direction and principles associated with the management of the YCA. It will provide the overall direction and concept of how the YCA will be managed in the future. The YCA Plan will provide a level of detailed planning to guide the ongoing land management of the YCA now, and after transfer to PV.

In undertaking this planning work in collaboration with the wider community, it is important to provide stakeholders with an understanding of what is negotiable and non-negotiable, so people are clear on the areas they can influence. Non-negotiables are based on the Government's response to the VEAC recommendations and will be communicated clearly and respectfully. There are also several matters where negotiation is possible, and this provides an opportunity to work closely with the community and ensure they are engaged in the process and have some ownership of local decisions on issues of concern.

An outline of the steps involved in the process of developing a YCA Plan is set out below:

- Use YCACC as the coordinating group;
- Review plans that currently apply to the area and determine the scope and content of the YCA Plan;
- Identify stakeholders and communities of interest;
- Meet with stakeholders:
- Prepare draft YCA Plan;
- Undertake public submission process;
- Review submissions and revise draft YCA Plan;
- Share findings through community consultation;
- Given the emphasis placed on collaboration and coordination in establishing the YCA, submit the revised YCA Plan to YCACC Agencies for endorsement (DELWP, PV, Zoos Victoria, Melbourne Water, PPWCMA, Yarra Ranges Council, Cardinia Shire Council, Trust for Nature, CFA, Wurundjeri Tribe Land Council; and
- Adopt final draft YCA Plan and release to the public.

Goals: To prepare and implement an effective YCA planning process across YCA.

To improve revegetation, pest plant and animal control, fire management planning and fire preparedness and on-ground staff presence particularly with a view to improving levels of compliance with regulations.

To connect the community with YCA and the value of biodiversity.



To convene an annual capital works planning workshop between a managers and agencies.

Performance indicators:

- YCA Plan developed and implemented; and
- Coordinated monitoring process established with responsible agencies.

8. Ongoing Resourcing of the Yellingbo Conservation Area

The purpose of establishing the YCA is to improve the ecological values within the area. These values include increasing the habitat for threatened species, improving and creating corridors for native species, increasing biodiversity and improving water quality. The YCA will include approximately 3,000 Ha of Crown land, currently in varying condition. It is not feasible for Parks Victoria to absorb the additional management burden of this land without additional funding.

The current funding allocation of \$3.2M will most likely be fully expended prior to ongoing land managers being appointed to manage the land, so a request for additional funding will be required to ensure that adequate funding is available to manage the land in accordance with the government's response to the VEAC report.

The YCA will be managed by a range of different land managers. It is intended that Parks Victoria will be appointed to manage most of the land, with other areas being managed by Zoos Victoria, Trust for Nature, DELWP and various committees of management.

It is proposed to use the development of a long-term YCA Plan for the YCA as the basis for developing a funding request. This will ensure that all land managers are identified and have been allocated sufficient funds to implement the YCA Plan in the areas they are responsible for managing.

Given the interim management of the land by DELWP, it should be possible to gauge a reasonable estimate of the resources required to manage the land to an acceptable level over the long term. That information will be used to develop a funding request to implement the YCA Plan.

Goal: To ensure that resources are available to implement the government supported recommendations of the VEAC Report.

Performance indicator:

- A request for funding has been prepared to support the implementation of the YCA Plan; and
- Funding has been sourced to allow the implementation of the YCA Plan by the land managers.

9. Monitoring, Evaluation and Reporting

There is clear evidence that natural resource management programs that invest in outcomes for land, water and biodiversity find it difficult to report to the community about the impact of the project. Therefore, well planned <u>monitoring</u>, <u>e</u>valuation and <u>reporting</u> (MER) can play an important role in supporting decision making that focuses on continuous improvement. Information generated from MER allows natural resource managers to adapt policies, programs and investment in response to risks and opportunities.




FIGURE 3: MONITORING, EVALUATION, REPORTING CYCLE



An MER will allow for adaptive management which is a systematic process for continually improving management practices through learning from the outcomes of previous management. The YCA Action Plan takes adaptive management to include (among other things) '...linking knowledge, management, evaluation and feedback over a period of time' 10

The YCACC and member agencies will have regard to the findings and recommendations of evaluations when implementing the YCA and when proposing any amendments. What is learned through monitoring and evaluation is expected to lead not only to an improved knowledge base and continuous improvement to biodiversity conservation with improved landscapes, healthy rivers, improved leisure and recreation opportunities, and confident communities, but to potential revision or refinement of strategic priorities, and a more efficient and effective application of public funds.

Performance indicator:

- Improvement in the status of threatened species as indicated by the monitoring of threatened species by the responsible agencies.
- The Development of a Monitoring, Evaluation and Reporting framework.

Role of YCACC in Monitoring, Evaluation and Reporting

The YCACC will monitor the implementation of the YCA process through its regular monthly meeting schedule.

Technical evaluation of the effectiveness of individual project works will be undertaken by the relevant lead agencies involved with the works and processes and reported to YCACC.

YCACC will review and evaluate engagement and communication strategies and outcomes and amend the Engagement and Communication plan at least annually or as required.

As a basis for evaluation and review the following data will be monitored:

- Newsletters produced;
- Database currency and requests to be included on the mailing list;



- Community consultation including sessions held and surveys /feedback sought;
- Press releases and press coverage;
- Website currency and traffic; and
- Works undertaken.

This information will form the basis for discussion at the evaluation Committee meeting.

Reporting of progress and outcomes will be undertaken by YCACC through its obligations to the Minister under its terms of reference, via its Annual Report.

Under these arrangements, it is envisaged that by the process of continuous improvement, the implementation of the YCA will be closely monitored and evaluated by the YCACC and subsequent actions modified considering experience and evidentiary reporting.



Appendix A

YCACC Terms of Reference

Definitions

1. In these Terms of Reference

Committee means the Yellingbo Conservation Area Coordinating Committee

Code of Conduct: means

The Code of Conduct issued by the Victorian Public Sector Standards Commissioner and made under section 61 of the Public Administration Act 2004, published here; and

The *Directors' Code of Conduct and Guidance Notes* issued by the Victorian Public Sector Commission (published at http//vpsc.vic.gov.au/resources/directors-code-of-conduct-andguideance-notes/)

Department: means the Department of Environment, Land, Water and Planning.

DPC Guidelines: means the *Guidelines for the Appointment and Recruitment of Part-Time Non-Executive Directors of State Government Boards and Members of Statutory Bodies and Advisory Committees* as issued by the Department of Premier and Cabinet — see the appointment and remuneration guidelines.

Member: means a member of the committee and includes a reference to the Convenor unless the contrary intention is expressed.

Minister: means the Minister for Environment, Climate Change and Water;

PAA: means the Public Administration Act 2004;

Public sector employee: has the meaning given in section 4(1) of the PAA.

Secretary: means the Secretary to the Department.

Establishment of the committee

2. The Minister establishes an inter-departmental committee, to be known as the Yellingbo Conservation Area Coordinating Committee, effective from the date of these Terms of Reference.

Functions

3. The functions of the committee are to



Improve coordination and collaboration between land managers and other agencies involved in the management of the Yellingbo Conservation Area (the area); and,

Establish strategic priorities and clear directions for the area to assist land managers, local government and the community, to work in partnership to achieve better environmental outcomes.

Accountabilities

- 4. To give effect to its functions the Committee will:
- Prepare the Yellingbo Conservation Area Action Plan for priority land management programs in the area;
- Be a consultation forum for the review of strategic or management plans prepared by represented public land managers for land within the area; and,
- Consider and advise represented public land managers on the means by which they may encourage complimentary management on adjacent private land.

Yellingbo Conservation Area Action Plan

- 5. The plan prepared by the committee will:
- Establish strategic priorities and clear directions for the area to assist land managers, local government and the community to work in partnership to achieve better environmental outcomes in the area;
- Articulate the links between the plan and strategic or management plans produced by represented public land managers;
- Subject to the endorsement of represented public land managers, establish priority land or biodiversity actions within the area that increase the profile of the biodiversity and ecological values of the area;
- Identify resources and partnerships essential to the achievement of the identified priority actions; and,
- Prioritise actions by consideration of the most efficient and effective application of public funds.
- 6. The committee will review and update the plan every three years. Three months prior to the expiration of a plan the committee will forward a copy of the proposed successor plan to the Minister, for in principle endorsement.
- 7. In preparing or reviewing the plan the committee will consult with reserve users and other relevant stakeholders.

Annual business plan

8. The committee will prepare a business plan each year, on or before 31 May.



- 9. The proposed business plan will include
- The nature and scope of the activities to be undertaken by the committee to address the functions specified in the terms of reference;
- The performance targets and other measures by which the performance of the committee may be judged in relation to its functions; and,
- Estimates of the expenditure required to support the operation of the committee for the financial year.

Annual Report

10. The committee will report to the Minister within three months of the end of each financial year on:

The committee's discharge of its functions, as described in these Terms of Reference;

The completion of actions prioritised by the plan; AND,

The committee's performance against the performance indicators and other measures in its annual business plan.

- 11. The Committee is subject to the general direction of the Minister in the performance of its functions.
- 12. Each member of the committee is required to comply with these Terms of Reference.
- 13. Each member of the committee must at all times act:
- In accordance with the codes of conduct; and,
- In a matter that is consistent with the public sector values in section 7(1) of the PAA.

Powers

14. The Committee may not enter into any agreements, contracts, employ staff, or hold or expend funds.

Timeframe

15. The Committee operates for ten years from the date of these Terms of Reference.

Membership

16. The Committee consists of:

A convenor;

Eight agency representatives – one from each of Parks Victoria, Melbourne Water, Yarra Ranges Council, Cardinia Shire Council, Department of Environment, Land, Water and planning, Zoos Victoria, Port Phillip and Westernport Catchment Management Authority; and Trust for Nature; and



Four community representatives (three nominated by Yarra Ranges Shire and one nominated by Cardinia Shire Council).

Term of appointment

17. A Member is appointed by the Minister for the term of office specified in his or her letter of invitation.

Remuneration and expenses

- 18. The Convenor and community representatives are entitled to receive remuneration for their services on the committee as set out in our letter of invitation.
- 19. Agency representatives are not entitled to remuneration.
- 20. A member other than any agency representative who is a public sector employee is only eligible to be paid remuneration in accordance with the DPC Guidelines.
- 21. No additional remuneration is payable to a member for time spent in preparation for meetings of the committee.
- 22. A member other than an agency representative is entitled to be reimbursed for reasonable travel and personal expenses related to their services on the Committee, at the rates that apply to employees of the department.

Removal from office and Vacancies

- 23. The Minister, without cause or notice, may remove a member from office at any time.
- 24. The office of a member becomes vacant if
- a member resigns in writing to the Minister;
- a member is removed from office;
- a member dies or in the opinion of the Minister, becomes incapable of performing his/her duties;
- a member becomes a bankrupt or a person disqualified from acting as a director or acting in management of a company;
- a member fails to attend 3 consecutive meetings without the permission of the convenor (in the case of the convenor without the permission of the Minister);
- a member fails to attend 75% of meeting over any given 12-month period without permission of the Minister (in the case of the convenor without the permission of the Minister); or,



- a nominating body advises that advises the Minister and their nominee, in writing, that it wishes to nominate a new person for appointment as a member to represent them.
- 25. Upon a vacancy occurring in the office of a member, the vacancy may be filled by the Minister in accordance with the Terms of Reference.

Meeting Procedure

- 26. Meetings of the Committee may be conducted in a manner determined by the Convenor subject to these Terms of Reference or any direction given by the Minister or the Secretary.
- 27. The quorum of a meeting consists of consists of a majority of the members present at a meeting.
- 28. If the Convenor is absent, or the office of Convenor is vacant, the members present at a meeting may elect from the members present a member to preside at that meeting.
- 29. The Convenor, or presiding member, must ensure, as far as practicable, that every member has adequate opportunity to participate in discussions.
- 30. Decisions of the committee will be sought through consensus. Where consensus is not achieved, the Chair may choose to initiate a vote of the Committee, with decisions to be determined by a majority.
- 31. Voting decisions can only occur with all members present, or out of session by agreement.
- 32. At the commencement of each meeting, the Convenor must enquire of all members whether there is any potential for a conflict of interest to Arise in respect to any item on the meeting agenda or any matter to be discussed and an interest held by a member.

Minutes

33. The Convenor must

Ensure that the minutes of each meeting are kept; and,

Circulate the minutes for comment by members before being formally adopted at the next meeting.

Conflicts of interest and other standards of conduct

34. The Committee must ensure that processes are in place to deal with conflicts of interest that-

Apply to both financial and non-financial interests; and,

Require full disclosure of interests at meetings of the board and the recording of the disclosure in the minutes of the meeting.

35. The Committee must have regard to the *Conflicts of Interest and Duty: A Practical Guide for Directors of Public Entities* issued by the Victorian Public Sector Commission (published at http://vpsc.vic.gov.au/html-resources/conflicts-of-interest-and-duty/) in its deliberations, proceedings or meetings.



- 36. A member who has a direct pecuniary or private interest in a matter being discussed at a meeting of the Committee must declare the nature of the interest and the potential for there to be a conflict: At the commencement of the meeting; or, If they become aware of an interest during discussions, as soon as possible after becoming aware of the interest.
- 37. A member who has made a declaration of a potential conflict of interest may not be present or take part in any discussion of the matter to which the declaration relates unless the Committee agrees otherwise.
- 38. A member who has made a declaration of a potential conflict of interest must not vote on the matter to which the declaration relates.
- 39. The Convenor or member presiding at a meeting at which a declaration of interest is made must cause the declaration to be recorded in the minutes of the meeting.
- 40. The Convenor must keep a record of declared interests. Any member may request and be granted access to this register of interests.
- 41. The Committee must ensure that it has a gifts and hospitality policy in place that conforms with the Department's Model Gifts, Benefits and Hospitality Policy (see gifts, benefits and hospitality).
- 42. The Committee must ensure that it has a dispute resolution policy in place that conforms with the Department's Model dispute resolution Policy (see dispute-resolution).

Time Commitment

43. Members are expected to attend a minimum of 75% of meetings.

Confidentiality and other duties of members

- 44. The requirements of section 79(2) & (3) and 81(1) © of the PAA apply to the Committee and its members as if the member is a director of a public entity, and the Committee is a public entity and the board of a public entity for the purposes of these provisions. The Minister may authorise the Committee to release specified information to third parties.
- 45. On the termination or expiry of a member's appointment, the member must return all documents relating to the Committee to the Convenor

Intellectual Property

46. The rights to Intellectual property created by the members of the Committee in the course of their duties on the committee, including any reports required under these Terms of Reference, is the property of the State of Victoria. However, The Minister on behalf of the State grants the Committee a license to use this property as authorised under these Terms of Reference. In this clause Intellectual property includes legal rights that protect the results of creative efforts including copyright, proprietary rights in relation to inventions (including patents), registered and unregistered trademarks, confidential



information (including trade secrets and know how), registered designs, circuit layouts, and all other proprietary rights resulting from intellectual activity in the industrial, scientific, literary or artistic fields but does not include moral rights.

Insurance

47. It is the responsibility of each member to ensure that he or she maintains adequate insurance in relation to their activities as a member of the committee

Secretariat support to the Committee

48. Parks Victoria will provide secretariat support to the Committee, and will act as the liaison between the Committee and the Minister.

Amendments and Revocation

- 49. The Minister may amend these Terms of Reference in writing at any time.
- 50. The Minister may revoke these Terms of Reference in writing at any time and upon revocation of these Terms of Reference the Committee ceases to exist.
